SHARPTOWN REGULAR MEETING MINUTES February 1, 2021

President Gosnell called the meeting to order at 7:30p.m. In attendance were Commissioners Bennett, Bradley, Henry, and Schneider, Clerk/Treasurer Schneider, Secretary Adkins, Joe Mangini, First Sgt. Mike Dolch, Attorney Mike Mathers, Jeff Merritt, and resident Nancy Springer.

Commissioner Henry made a motion to approve the minutes from the December 21st meeting, which seconded by Commissioner Schneider. All were in favor, so carried.

Commissioner Bennett made a motion to pay the bills as stated on pages 4 and 5 which was seconded by Commissioner Bradley. All were in favor, so carried.

OLD BUSINESS:

President Gosnell signed the deed to donate the 502 Nanticoke Street property at Operation We Care. Jeff Merritt gave an update on the "Home for a Hero" house being built on State Street. He stated the materials have been ordered and framing is expected to begin soon.

Attorney Mathers stated the settlement to purchase the Old School could be scheduled the week of February 8th. President Gosnell will contact the owner to schedule a date.

President Gosnell asked for an update on the annexation request. Secretary Adkins stated a meeting with Planning and Zoning be held before the next Commissioners meeting to make recommendation to the Commissioners.

Circuit Rider Joe Mangini stated the Town will be granted their request to the County to have the taxes paid to purchase 502 Nanticoke Street refunded. They are determining the best way to handle it. Mr. Mangini also stated he will reach out to see if Bhaskar is back to work to get an update on the shoreline restoration project.

NEW BUSINESS:

The Town Hall will be closed on Monday February 15th in observance of Presidents Day. The next Commissioners meeting will be held Tuesday February 16th.

President Gosnell stated DBF has applied for a grant from MDE to replace the sewer plant.

First Sgt Dolch from the Wicomico County Sherriff's Department read the Towns crime statistics. He stated speed enforcement had been done on State Street at Twiford Road. The average speed was 29 MPH. Another trip will be scheduled.

President Gosnell asked for Commissioners comments. Commissioner Bennett stated the Historical Commissioner will be meeting on February 8th. Nancy Springer stated that the town banner on State Street had blown away and the one on Church Street/Taylor Street has come loose.

President Gosnell asked for public comment. There were none.

Commissioner Bradley made a motion to adjourn the Commissioners meeting, which was seconded by Commissioner Schneider. All were in favor, so carried.

President Gosnell adjourned the meeting at 7:51p.m.
