

**SHARPTOWN REGULAR MEETING
MINUTES
May 21, 2018**

Commissioner Bradley called the meeting to order at 7:30p.m. In attendance were Commissioners Schneider, Henry, Clerk/Treasurer Schneider, Secretary Adkins, Aaron Goller from Davis, Bowen, and Friedel, and resident Jean Cordrey. President Gosnell and Commissioner Bennett were absent.

Commissioner Schneider made a motion to approve the minutes from the May 7th regular meeting. A second was made by Commissioner Henry. All were in favor and chair voted aye, so carried.

Commissioner Schneider made a motion to pay the bills as stated on pages 4 and 5, which was seconded by Commissioner Henry. All were in favor and chair voted aye, so carried.

OLD BUSINESS:

Mr. Goller updated the Commissioners on the solar project. The landscaping is due to be done soon, AltEnergy needed to find a new contractor to do the work. The net metering has been approved by Delmarva Power and the Town will be notified when able to use the system, which would take up to 21 days. He contacted MDE about the payments and they stated the payments are being processed through the system.

Mr. Goller updated the Commissioners on the Dollar General/Pecan Corner work. The store has it water hooked up and a temporary sewer hookup. They are having a soft opening of the store on Sunday May 27th. TK Construction is putting in the new sewer line on State Street from Railway to Taylor Streets, which weather permitting, should be done in less than two weeks.

The Commissioners reviewed an email from Circuit Rider Joe Mangini on what he has been working on.

The Commissioners will hold a 2018/2019 FY Budget work session on May 22nd at 7pm.

NEW BUSINESS:

Clerk/Treasurer Schneider stated the town trash removal contract is up this year. She has advertised for bids being accepted, which will be opened on May 29th at 2pm.

Commissioner Bradley asked for Commissioners comments. Commissioner Schneider stated the open space grant that the Parks and Recreation applied for was approved for FY 2019 in the amount of \$13463.00, which will replace the roof and the tables and benches at the Cherry Beach pavilion. If funds allow, the roof on the old concession stand will be replaced also.

Clerk/Treasurer Schneider stated Wicomico County Sheriff Deputy, and Sharptown resident, Steve Ray has passed away. His viewing will be May 23rd at Holloway Funeral Home, and his funeral will be May 24th at Allen Memorial Baptist Church.

Commissioner Bradley asked for public comments. Mrs. Cordrey stated recently Mardela Springs had a town clean up day. Chesapeake Waste went house to house and picked up the discarded items, instead of the residents bringing the items to a large dumpster. She suggested the Town see if they would include a price in their trash bid for doing the same here in Sharptown.

There were no other comments. Commissioner Schneider made a motion to adjourn, which was seconded by Commissioner Henry. All were in favor and chair voted aye, so carried.

Commissioner Bradley adjourned the meeting at 7:46pm.
